Re: Memorialize the New York State Legislature and Governor Cuomo to Amend New York State Sex Offender Registration Act to Notify Citizens When a Sex Offender is Re-located to a State-Owned Facility Within a Community.

Honorable Legislators:

In 1996, the New York State Legislature passed the Sex Offender Registration Act, New York's version of Megan's Law. This requires sex offenders to register themselves with the State, providing information such as place of residence, employment, and other personal information. This information is made public, allowing citizens to educate themselves to protect their neighborhoods and families.

Section 168-j of this Act ensures that any changes to a sex offender's location will be communicated to the law enforcement most directly affected by these changes. While this law applies directly to privately-owned residences, it is not required in the case of relocation between state-owned facilities. Therefore, when sex offenders were moved from the Monroe Development Center to a group home in Scottsville operated by the Office for Persons with Developmental Disabilities, the State was not required to inform any local law enforcement of the relocation, despite the latter being located in a residential neighborhood.

This loophole in the Sex Offender Registration Act must not be allowed to stand. It is the duty of the State to provide private, law-abiding citizens with knowledge that allows them to build safe communities. Failure to inform residents when convicted sex offenders move into their neighborhood damages the trust between government and people.

I urge you to join me in Memorializing the New York State Legislature and Governor Cuomo to Amend New York State Sex Offender Registration Act to notify citizens when a sex offender is re-located to a State-owned facility within a community. This amendment will rebuild the trust lost by New York State residents and will ensure that citizens are informed on the presence of sex offenders in their communities.

Subject: Amend Resolution 69 of 1989 to Revise the M/WBE Policy Statement for Monroe County Capital Projects

Honorable Legislators:

I recommend that this Honorable Body amend Resolution 69 of 1989 to revise the minority-owned business enterprises (MBEs) and women-owned business enterprises (WBEs) policy statement for Monroe County capital projects. The current goals for levels of participation are; 10% participation for MBEs, and 2% for WBEs. The revised policy statement will set the goal of participation to 12% for MBEs and 3% for WBEs.

Specifically, this legislation will establish new goals for levels of participation for minority and women-owned businesses enterprises (M/WBEs) to allow each the potential to earn from the total annual County construction expenditures on infrastructure projects funded by the Capital Budget. The projects include road, bridge, sewer, new building construction or renovation encompassing all of the various construction trades. The new M/WBE goals continue the County's good-faith efforts to hire local labor and create local jobs, whenever possible through the capital program.

In addition, the new policy statement will require prime contractors, which are awarded the contract, to file an M/WBE utilization plan before the construction contract is executed by the County Executive. Lastly, to monitor the effect of this policy statement, the County Executive, or her designee, will be required to file a report with the County Legislature no later than April 1st of each year that details the levels of participation for M/WBEs contractors on construction projects funded by the Capital Budget in the prior year.

The specific legislative actions required are:

1. Amend Resolution 69 of 1989 to Revise the M/WBE Policy Statement for Monroe County Capital Projects by deleting the current language in its entirety and replacing it with the following:

"The Monroe County Legislature hereby adopts the following policy statement for insuring the full and equitable participation of Minority and Women owned businesses in construction activities:

1) Monroe County will have a level of participation goal of twelve (12) percent for Minority-owned Business Enterprises (MBEs) for annual County construction expenditures funded by that given year's Capital Budget.

2) Monroe County will have a level of participation goal of three (3) percent for Women-owned Business Enterprises (WBEs) for annual County construction expenditures funded by that given year's Capital Budget.

3) The above 12% and 3% goals will continue the County's good faith efforts to utilize local labor and create local jobs for County construction projects.


4) All companies to be awarded prime construction contracts on a construction project to be funded by the Capital Budget must file an M/WBE utilization plan with the County Executive's designee before contract execution by the County Executive.

5) The County Executive, or her designee, will file a report with the County Legislature no later than April 1st of each year, which details the levels of participation for M/WBEs contractors on construction projects funded by the Capital Budget in the prior year. The report will include the name of each project funded, the total construction dollars spent for the project and total dollars spent with minority and women owned businesses, respectively.

This policy initiative will have no impact on this year's Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by this Honorable Body.

Honorable Legislators:

One of the most basic ways in which we can honor our nation's veterans is to offer them comprehensive medical services and other necessary benefits for both themselves and their families. For all these reasons and more, the bill has earned the support of our nation's most venerable veteran's advocacy groups, including the American Legion, the Veterans of Foreign Wars and Disabled American Veterans.

These proposed changes crucial to improving the lives of veterans and their families who have made countless sacrifices defending the United States of America. Therefore, I urge you to

join me in memorializing the U.S. Congress to pass and President Barack Obama to sign S.1950, the Comprehensive Veterans Health and Benefits and Military Retirement Pay Restoration Act of 2014.







RE: Memorializing the Rochester-Genesee Regional Transportation Authority (RGRTA) to Initiate a Bus Transfer System for Routes that Pass through Downtown but Will Now Stop at the New Bus Station

Honorable Legislators:


The new bus station downtown is going to be a wonderful asset for our community. No longer will people have to congregate on street corners downtown in all types of weather. Instead, bus riders will have a state of the art facility indoors to wait for and catch buses. Not only that, the re-development of an under-utilized city block is always a welcome sight in the heart of downtown.

In the ideas for service changes, however, is a proposal that will have a disturbing consequence. The proposal will terminate all routes at the Central Station, meaning that there will no longer be routes that continue through downtown, such as the Lake Ave./Park Ave. route or the Dewey Ave./ Portland Ave. route. This means that all passengers traveling through downtown will have to disembark at the Central Station and re-board buses paying a second fare. This will impact 7.5% of riders currently (an estimated 1.3 million riders a year), and even more when Monroe Community College moves its downtown campus from the Damon Center to the Kodak site. Many of these commuters have chosen their places of residence and work to coincide with these routes, and cost increases will be burdensome.

The fact that RGRTA is willing to increase some commuters' fares by 100% (50% if they buy an all-day pass) is all the more vexing given their current financial prosperity. Not only did RGRTA have net working capital of \$35,691,000 as of March 31, 2013, but they provided free shuttle services for the PGA Championship as a show of good will at an estimated cost of \$600,000.

Therefore, I urge you to join me in calling on RGRTA to keep fares consistent and implement a bus transfer system for current routes that pass through downtown, but will now terminate there, so that riders aren't forced to pay twice due to this change in scheduling.

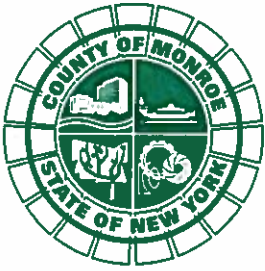

Honorable Legislators:


The majority of men and women in New York who earn minimum wage are hard-working adults who often are unable to escape the cycle of poverty associated with low-paying jobs. The proposed Minimum Wage Fairness Act would increase the minimum wage and change the lives of those workers and their families while increasing consumer spending and creating jobs.

The legislation would amend the Fair Labor Standards Act of 1938 (FLSA) to increase the federal minimum wage for employees to: (1) \$8.20 an hour beginning on the first day of the sixth month after enactment, (2) \$9.15 an hour beginning one year after the date of the initial increase, (3) \$10.10 an hour beginning two years after such date, and (4) the amount determined by the Secretary of Labor (based on increases in the Consumer Price Index) beginning three years after such date and annually thereafter.

According to co-sponsor Kirsten Gillibrand, nearly 1.8 million New Yorkers earning the minimum wage or just above. This is significant as the number of Americans in poverty has increased dramatically in recent years due to the Great Recession. It is estimated that a person in New York working 40 hours a week, 52 weeks a year at the minimum wage, earns just \$290 a week. That's \$15,000 a year – without any time off. That salary is \$3,000 below the poverty line for a family of three. It is the responsibility of elected officials to implement solid economic policy in order to raise families out of poverty and it is critically important that this bill is enacted into law.

Therefore, I urge you to join me in memorializing the United States Congress to pass, and President Barack Obama to sign S.1737, the Minimum Wage Fairness Act.





Subject: 2014 Annual Action Plan for Housing and Community Development in Suburban Monroe County and Grant Submission to the U.S. Department of Housing and Urban Development

Honorable Legislators:

I recommend that Your Honorable Body approve Monroe County's 2014 Annual Action Plan for Housing and Community Development in Suburban Monroe County and Grant Submission to the U.S. Department of Housing and Urban Development (HUD) for the Community Development Block Grant (CDBG), Home Investment Partnerships Program (HOME) and Emergency Solutions Grants (ESG) programs.

Approval of this submission by HUD will provide the County with funding in the amount of \$2,671,852 for the period August 1, 2014 to July 31, 2015. This represents the combined total of funds for the CDBG Program in the amount of \$1,653,925; the HOME Program in the amount of \$882,780; and, the ESG Program in the amount of \$135,147. This year's allocations represent an overall increase of \$64,349 from last year. This is the 39th year the County will receive this funding.

The CDBG, HOME and ESG programs have been designed to carry out neighborhood projects, Americans with Disabilities Act (ADA) improvements to public facilities, community services, economic development activities, housing activities, and homeless services. Pursuant to HUD regulations, these programs must principally benefit low to moderate-income persons, the elderly and persons with special needs who live in the towns and villages that participate in the Monroe County Community Development Consortium.

Members of the Consortium and community services agencies apply to the County to receive grants for projects, which are listed in the 2014 Annual Action Plan.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to submit the 2014 Annual Action Plan to the U.S. Department of Housing and Urban Development (HUD) and to provide such additional information as may be required by HUD for the Community Development Block Grant, Home Investment Partnerships Program and Emergency Solutions Grants programs.
2. Authorize the County Executive, or her designee, to accept the grant funds in the amount of \$2,671,852 or such other amount as determined by the U.S. Department of Housing and Urban Development (HUD), subject to HUD approval of the submission.


3. Appropriate the sum of \$2,671,852 for grant funds, or such other amount as determined by the U.S. Department of Housing and Urban Development (HUD), and the sum of \$350,000, which is the estimated Program Income expected to be generated during the program year, into fund 9005; funds center 1501010000, Community Development Grants, contingent on HUD approval.
4. Authorize the County Executive, or her designee, to execute all contracts, including intermunicipal agreements, and any amendments thereto, that are necessary to carry out the administration of the Community Development Block Grant, Home Investment Partnerships Program and Emergency Solutions Grants programs.
5. Authorize the County Executive, or her designee, to execute all agreements, debt instruments, and other documents for each loan, grant, relending project or activity which may be approved under the U.S. Department of Housing and Urban Development (HUD) Section 108 Loan Guarantee Assistance program, pursuant to Section 168.00 of the Local Finance Law, and to accept, receive and reappropriate funds which are borrowed from HUD or any other party, and relend the same to qualified borrowers.
6. Authorize the County Executive, or her designee, to approve the use of contingency funds or funds reprogrammed from current or prior years pursuant to U.S. Department of Housing and Urban Development regulations.
7. Authorize the County Executive, or her designee, to accept, receive and appropriate or reappropriate any funds which accrue to the Community Development Office in the form of program income for use in connection with programs offered or funded by the Community Development Office, which administers the grants. All such income shall be utilized in accordance with U.S. Department of Housing and Urban Development regulations governing the use of program income.
8. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
9. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify such program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this grant and it was determined that there would be no significant effect on the environment.

This grant is 100% funded by the U.S. Department of Housing and Urban Development. No additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

Honorable Legislators:

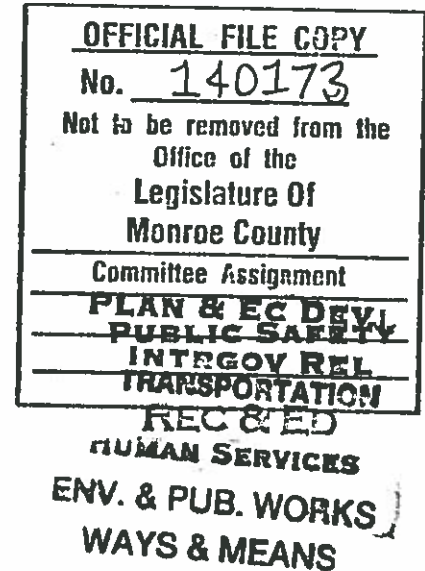
I recommend that Your Honorable Body adopt the proposed 2015-2020 Capital Improvement Program as recommended by the Monroe County Planning Board. The proposed Capital Improvement Program is submitted to the County Legislature in accordance with Section C4-10 of Article IV and Section C5-7 of Article V of the Monroe County Charter.

This proposed program includes projects designed to address aging infrastructure while at the same time ensuring that Monroe County continues to grow and expand its job base and quality of life. Projects contained in the program are intended to improve and modernize public buildings, construct needed highway and bridge improvements, as well as continued investment in the Greater Rochester International Airport, County parks, the Monroe County Library System and Monroe Community College.

The 2015-2020 Capital Improvement Program is the result of a team effort involving the County Executive's Office, the Engineering Division, and the Departments of Planning and Development, Finance, Transportation, Law, and Information Services. In addition, the Monroe County Planning Board put in many hours in reviewing and recommending this program. I want to thank all of those involved in the preparation of this program for their hard work and dedication.

The specific legislative actions required are:

1. Fix a public hearing on the adoption of the proposed 2015-2020 Capital Improvement Program.



2. Direct the Clerk of the Legislature to publish legal notice of such public hearing at least once in one daily newspaper of general circulation in the County at least ten (10) days before the date set for the hearing.
3. Adopt the proposed 2015-2020 Capital Improvement Program, as submitted, in its entirety.

Environmental assessments were completed for the 2015-2020 Capital Improvement Program and it was determined that there would be no significant effect on the environment.

The adoption of the proposed 2015-2020 Capital Improvement Program will have no impact on the revenues or expenditures of the current Monroe County budget.

Subject: Acceptance of a Grant from New York State Office of Indigent Legal Services for the Offices of the Public Defender and the Conflict Defender for the Caseload Reduction Program

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Office of Indigent Legal Services, in the amount of \$299,528, for the Office of the Monroe County Public Defender and the Office of the Monroe County Conflict Defender, for the Caseload Reduction Program, for the period of January 1, 2014 through December 31, 2016.

This grant will provide funding for the salary and benefit costs equivalent to one (1) new full-time position in the Office of the Monroe County Public Defender. This grant will also provide funding for appeals attorney contractual services in the Office of the Monroe County Conflict Defender. We have been notified of the funding amounts for the Office of the Monroe County Public Defender, 9300-2601010000 (\$209,442), and the Office of the Monroe County Conflict Defender, 9300-2402010000 (\$90,086) over a three (3) year period. This is the first year the County has received this grant.

The specific legislative actions required are:

1. The purpose of this grant is to reduce the incidence of lead poisoning in Monroe County children by the identification and safe correction of lead hazards in housing units before a child is poisoned. Funding will support lead visual inspections and risk assessments performed by Monroe County Department of Public Health Lead Risk Assessors in areas of high risk, in residences of pregnant women and refugees, in residences funded by Monroe County Department of Human Services clients with young children, and in residences who have blood lead levels between 8-14 ug/dl. Funds will also be used to contract with the City of Rochester to conduct primary lead poisoning prevention activities in City target areas, including: visual lead inspections, dust wipe sampling, and clearance testing following lead hazard control activities. In addition, funds will be used for vendor contracts to: support lead safe work practices training; provide outreach and education in environmental home safety; provide lead primary prevention education; provide lead safe housing for refugee families. This will be the eighth year the County has received this grant. This year's funding represents an increase of \$92,766 from last year.

Requests for Proposals were issued for these services and Schneider Laboratories Global, Inc., Cornell University and Catholic Family Center were selected as the most qualified to provide the vendor services.

The New York State Office of Children and Family Services contracts with the New York State AFL-CIO Workforce Development Institute to administer a facilitated enrollment program in Monroe County, however, applications are processed and subsidy payments are made through the Monroe County Department of Human Services. The demonstration program seeks to make the process of applying for child care subsidies easier for working parents and to expand access to child care subsidies for working families with income up to 275% of State Income Standards. New York State AFL-CIO Workforce Development Institute will facilitate initial applications and enrollment activities. Staff from the Department of Human Services will make final eligibility determinations for these cases and process subsidy payments. This is the tenth year the County has received this funding. This year's funding represents the same amount as last year's allocation.

Honorable Legislators:

Moved into the plastic injection molding industry, holding positions as Engineering Manager and Project Engineer. The last 5 years at that company held the position of Vice President and Operations Manager running the Rochester Operations.

Throughout career, owned own engineering and consulting company and worked exclusively in the plastics field. Projects included manufacturers needing direction on handling their plastics production and reducing scrap generated on their production lines, and plastic recycling.

2003: Left full time position as VP of the injection molding company to dedicate full time to his own consulting company, Empire Resource Recycling.

Quickly expanded Empire Resource Recycling from a consulting company to a broker of industrial plastic scrap realizing a need for warehousing and grinding operations to improve the bottom line to local clients and increase material value to the end users. Established a full time Operations inside the Monroe County Resource Recycling Facility.

2005: Expanded Empire Resource Recycling family to include X Ray Recycling and File Management Division collecting X Ray files, industrial films and micro film with a nationwide program to collect from hospitals and companies. Currently, services clients from as far as California and Florida. The operations for X Ray Recycling are located on Buffalo Road.

2007: Due to the difficulty in handling and shipping Industrial film, added film pelletizing, basically re-extruding industrial film into reusable pellets for product manufactures. The film manufacturing operation is currently located in the former Valeo /AC Delco Business Park on Lyell Ave.

2012: Realizing the volume of "dirty mixed rigid" plastics that was being collected and shipped overseas from the Rochester area, designed and built a plastics wash line that shreds, grinds and washes bulky rigid plastics. The operation is currently located in the Monroe County Resource Recycling facility on Emerson St.

2014: Seeing a need to offer options above and beyond plastics recycling and the need, in certain industries, to supply alternatives that support recycling, started the "Empire Resource Partners" division. Through a joint venture with the manufacturer of Oshenite (a renewable, high grade calcium that is mined from the ocean). Have an exclusive contract to sell this filler as an alternative to virgin PVC and HDPE in the extrusion industry.



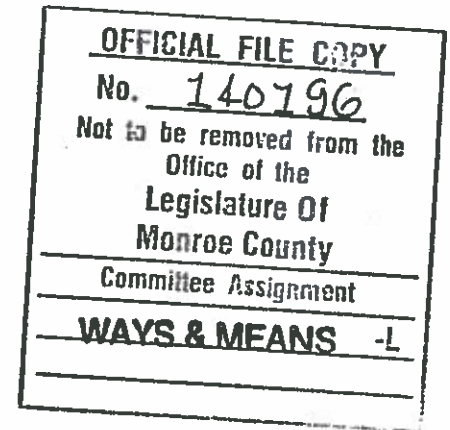
