Re: Memorializing the New York State Legislature to Pass, and Governor Andrew M. Cuomo to Sign, Assembly Bill A5130 and Senate Bill S3224, An Act to Amend the General Municipal Law, in Relation to Authorizing Reduction of Premiums for Municipal Cooperative Health Benefit Plans

Honorable Legislators:

In the past decade, health insurance costs are among the fastest growing expenses for local governments and municipalities. Compared to other states, New York ranks sixth with the highest health insurance premiums in the country. In an attempt to consolidate operations to help improve efficiency and reduce costs to taxpayers, municipalities have worked to create health insurance consortiums to jointly self-fund their health plans which will provide significantly lower costs of health insurance for taxpayers.

Considering the high expense of New York's health insurance costs, municipal health insurance consortiums could provide cost savings for counties who have been over burdened with other costs. Both Assembly Bill A5130 and Senate Bill S3224 would give municipalities the tools that are needed to cooperatively provide services and administer municipal employee benefits at lower costs, which have the potential of providing significant savings.

Both bills would amend general municipal and insurance law in order to enhance the ability of municipalities to join forces and cooperatively provide and manage employee benefits. These much needed reforms would enhance services to residents, all while easing the burden on municipalities who have been burdened with unfunded mandates.

Therefore, I urge you to join me in memorializing the State Legislature, as well as Governor Andrew M. Cuomo, to implement reforms by passing Assembly Bill A.5130 and Senate Bill S.3224, which will allow municipalities to join together and provide quality health insurance and ease the burden on local governments with costs associated with health premiums.





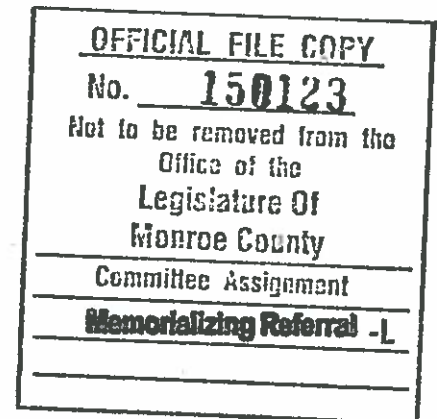

RE: Memorializing the New York State Senate to Pass, and Governor Cuomo to Sign, S.4102, the Child Safe Products Act, an Act to Amend the Environment Conservation Law to Regulate Toxic Chemicals in Children's Products.

Honorable Legislators:

There has been growing concern across the state, from families, advocates, and lawmakers alike, about children's exposure to toxic chemicals in their toys, clothes, and other products. Exposure to chemicals such as cobalt and cadmium are linked to serious health issues like cancers, respiratory issues, and learning disabilities.

The Child Safe Products Act is a bill that will provide for greater regulation of the chemicals used in children's products by initially banning nine chemicals and compounds from being used by children's products manufacturers. Products would include baby products, children's toys, bedding, jewelry, and apparel.

Further, the bill will require the Departments of Environmental Conservation (DEC) to create a list of priority and high concern chemicals on its website. The bill will also require manufacturers to report to the DEC and to retailers if their products contain any of the chemicals on the list.

Clean & Healthy New York, and advocacy group, recently released a report on their findings of toxic toys and products purchased in Monroe County. The group tested items from several area retailers in which the following dangerous chemicals were detected: arsenic, antimony, cadmium, cobalt and mercury. It is essential that our legislative bodies take action and make the safety and welfare of children their top priority.

Therefore, I urge you to join me in memorializing the New York State Senate to pass, and Governor Cuomo to sign S.4102, an act to amend the Environment Conversation Law to regulate toxic chemicals in children's products.





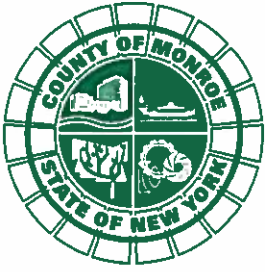

Honorable Legislators:


As the largest system of fresh surface water in the world, the Great Lakes have been a life sustaining asset for human settlement as well as an economic driver for the Midwest and Northeast. To this day, tens of millions of Americans rely on the Great Lakes for commerce, drinking water, transportation, and recreation. Unfortunately, the development and industrialization has also left a legacy that includes many environmental challenges for the communities surrounding them.

For that reason, in 2010, President Obama launched the Great Lakes Initiative to accelerate efforts to protect and restore the Great Lakes. The initiative has provided various agencies with money to pay for projects including habitat restoration, toxic-sediment cleanup, and invasive species control. Since the initiative's start, it has provided roughly \$1.9 billion in funding.

As expected, the Obama Administration has included funding to continue this important work in the upcoming budget. However, the proposal is for \$250 million, falling \$50 million short of the current year's funding. In response, a bi-partisan group of Congressmembers, including Congresswoman Louise Slaughter, have written a letter to the Chair and Ranking Minority Member of the House Appropriations Committee urging them to restore funding to \$300 million. Lake Ontario is a vital resource for Monroe County, as a commercial seaway, a recreational destination, and a source for fresh water.

Therefore, we urge you to join us in calling on the House Appropriations Sub-Committee on Interior, Environment, and Related Agencies to continue to fund the Great Lakes Restoration Initiative at the current year's level





RE: Memorializing the New York State Senate to Pass, and Governor Cuomo to Sign S.3004, an Act to Amend the Workers' Compensation Law and the Insurance Law in Relation to Paid Family Leave.

Honorable Legislators:

Hard work and dedication to one's job are attributes that keep New York State's workforce strong. However there are times, either joyous or tragic, where a paid leave of absence from a person's job could not only be necessary, but life-changing.

Paid family leave would allow for time off for men and women who have had the arrival of a new child, become seriously ill, or choose to take care of a family member who is seriously ill. Currently there are only three States in the US – California, New Jersey, and Rhode Island – that provide all employees with paid family leave. If New York were to become the fourth state, it would be an important step in providing equality in the workplace as well as promoting family health and economic stability.

This bill would allow for a maximum of twelve weeks of paid time off for employees in the State of New York in which they would be guaranteed half of their regular pay. The funding would come from requiring employees to purchase paid family leave insurance from their employer with a weekly contribution of up to forty-five cents.

Paid family leave would give parents the gift of more time to bond with a new child, eliminate the fear of losing one's job while combating a severe illness, and provide the option of becoming a care giver to a family member in a time of need.

Therefore, I urge you to join me in memorializing the New York State Senate to pass, and Governor Cuomo to sign S.3004, an act to amend the Worker's Compensation Law and the Insurance Law in relation to Paid Family Leave.





Subject: Acceptance of a Grant from the New York State Division of Criminal Justice Services for the Crimes Against Revenue Prosecution Program

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of District Attorney Sandra Doorley.

I recommend that Your Honorable Body accept a grant from the New York State Division of Criminal Justice Services, in the amount of \$228,280, to continue the Crimes Against Revenue Prosecution Program in the District Attorney's Office, for the period of January 1, 2015 through December 31, 2015.

This grant will provide funding to support a portion of the cost of three (3) full-time Assistant District Attorneys, and one (1) full-time Criminal Law Assistant, to both investigate and prosecute individuals and businesses operating in Monroe County that violate tax laws, to reclaim revenue lost due to non-compliance with State tax laws, and to increase voluntary compliance with applicable tax laws. Crimes involving the failure to pay New York State sales and income taxes lawfully owed, the failure to report New York State taxable income, and fraud involving welfare, unemployment insurance benefits, and workers' compensation payments will all be investigated and prosecuted by project staff. The funding also covers the costs of travel for the purpose of training project staff about issues related to crimes against revenue. This will be the tenth year that the County has received this grant. This year's funding represents an increase of \$22,280 from last year.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$228,280 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services for the Crimes Against Revenue Prosecution Program in the District Attorney's Office, for the period of January 1, 2015 through December 31, 2015.

2. Amend the 2015 operating grant budget of the District Attorney's Office, by appropriating the sum of \$22,280 into fund 9300, funds center 2510010000, Economic Crime Bureau.
3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Environmental assessments were completed for this grant and it was determined that there would be no significant effect on the environment.

Partial funding for this grant is included in the 2015 operating grant budget of the District Attorney's Office, fund 9300, funds center 2510010000, Economic Crime Bureau. The appropriated amount will adjust the current funding to that established by the grant.

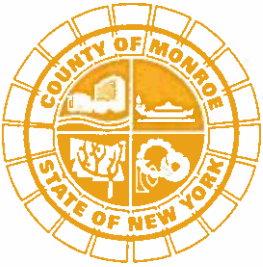

Subject: Acceptance of Three Alternatives to Incarceration Grants from the New York State Division of Criminal Justice Services for the Pretrial Program, Enhanced Pretrial Program, and Domicile Restriction Program

Honorable Legislators:

I recommend that Your Honorable Body accept three (3) Alternatives to Incarceration (ATI) grants from the New York State Division of Criminal Justice Services, the first in the amount of \$170,494, for the Pretrial Program, the second in the amount of \$105,533, for the Enhanced Pretrial Program, and the third in the amount of \$51,961, for the Domicile Restriction Program, all for the period of July 1, 2015 through June 30, 2016.

The goal of all ATI programs is to reduce recidivism, promote public safety, and enhance defendant/offender accountability through community corrections. Monroe County Probation Officers and Pretrial Services Corporation staff interview defendants to determine if any ATI programs would be appropriate for the defendant.

The Pretrial Program provides universal screening for all defendants arrested and detained in the Monroe County Jail. The program staff interview defendants, verify information given and communicate that information to the Court in order to assist a qualified defendant in obtaining release on his/her own recognizance in lieu of money bail or pre-trial detention. If the defendant is released to the program, he/she is monitored to ensure attendance at subsequent Court appearances.

The Enhanced Pretrial Program provides intensive monitoring of a defendant by an individual case manager. An additional treatment component may be required of the defendant. The Program team links defendants with treatment programs, monitors defendant progress, and makes recommendations to the court for adjustment/modification. Monitoring occurs through personal and telephone contacts and continues at least twice per week until case disposition.

The Domicile Restriction Program provides an alternative to incarceration by the use of electronic monitoring of offenders. The program includes traditional phone monitoring, Global Positioning System monitoring and alcohol sensing equipment for high-risk offenders. By placing offenders in this program, the County saves money, and the offender has the opportunity to continue their employment, schooling, and/or treatment and maintain familial ties, thereby reducing their chance of re-offending.

The two (2) pretrial programs will be provided by Pre-Trial Services Corporation of the Monroe County Bar Association. The Domicile Restriction Program will be administered by staff from the Monroe County Office of Probation - Community Corrections. This will be the twenty-third year that the County has received these grants. This year's funding represents the same amount as last year.

Authorize the County Executive, or her designee, to accept a \$51,961 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Criminal Justice Services, for the Alternatives to Incarceration Grant, for the Domicile Restriction Program, for the period of July 1, 2015 through June 30, 2016.
4. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
5. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.

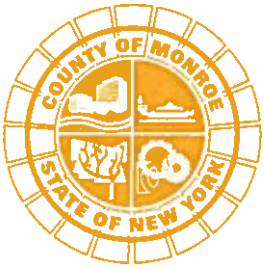

Subject: Authorize a Contract with Health Care Support Advisors, Inc. for the Monroe County Sheriff's Office to Conduct Criminal Background Checks on Health Care Support Advisors, Inc. Members' Potential Employees

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body authorize a contract with Health Care Support Advisors, Inc. (HCSA), in an amount not to exceed \$80,000, for the Sheriff's Office to conduct criminal background checks on potential employees of nursing homes which are served by HCSA, for the period of June 16, 2015 through June 15, 2016, with the option to renew for two (2) additional one-year periods upon mutual consent of both parties. Each renewal will be for an amount consistent with the Sheriff's costs to provide the requested service.

HCSA is a not-for-profit corporation that provides support (i.e. education, scholarship grants to employees, criminal background checks) to for-profit and not-for-profit skilled nursing facilities. This agreement will allow agencies served by HCSA to have background checks performed by the Office of the Sheriff on all of their prospective employees in order to identify those who have a criminal record. The purpose of this endeavor is to help the participating homes and hospitals in their effort to safeguard their residents and enhance the quality of care provided to them. The amount paid by HCSA will allow the Monroe County Sheriff's Office to fund one (1) or more full-time clerks to perform this important function.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Health Care Support Advisors, Inc. (HCSA), 40 Barrett Drive, Webster, New York 14580, for the Sheriff's Office to conduct criminal background checks on potential employees of nursing homes which are served by HCSA, in an amount not to exceed \$80,000, for the period of June 16, 2015 through June 15, 2016, with the option to renew for two (2) additional one-year periods upon mutual consent of both parties. Each renewal will be for an amount consistent with the Sheriff's costs to provide the requested service.

Environmental assessments were completed for this contract and it was determined that there would be no significant effect on the environment.

Funding for these services is included in the 2015 operating budget of the Office of the Sheriff, fund 9001, funds center 3806010000, Staff Services Administration. No additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

Subject: Authorize an Intermunicipal Agreement with the Fairport Central School District for the Purchase of Fuel for Vehicles of the Monroe County Sheriff's Office

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body authorize an intermunicipal agreement with the Fairport Central School District for the purchase of fuel for Monroe County Sheriff's Office vehicles, for the period of September 1, 2015 through August 31, 2016, with the option to renew for three (3) additional one-year periods, at the rate of ten cents (\$.10) per gallon above the New York State contract price.

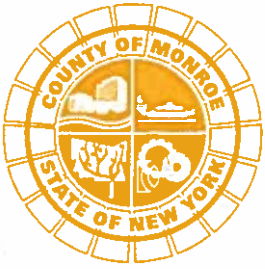

The Monroe County High Accident Location Program consists of a detailed analysis of each location identified as a Priority Investigation Location, identifying and evaluating potential countermeasures, and developing specific safety recommendations. Locations, if not recently studied for some other purpose, are analyzed to determine if there are any accident patterns, how persistent they are, what may have caused the accidents, and what countermeasures would be appropriate to improve safety at the location. This is an active program for Monroe County to monitor the safety performance of the road network. This year's funding represents an increase of \$9,000 from last year.

Existing Public Health Emergency Preparedness staff will coordinate and direct program objectives which include the following: plan for and sustain local Ebola monitoring activities; plan for and respond if necessary for Isolation and Quarantine operations (wrap around activities); plan for and respond if necessary to environmental clean-up operations; participate in a Health Preparedness Coalition tabletop exercise; purchase required personal protective equipment (PPE); conduct required PPE training; and deliver Ebola Virus Disease Risk Communication Messages. Funds will be used to support salary, benefits, contracts, staff training, and other program costs. This will be the first year the County has received this grant.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$200,000 grant from, and to execute a contract and any amendments thereto with, Health Research, Inc., for the PHEP Ebola Preparedness and Response Activities Program, for the period of April 1, 2015 through September 30, 2016.
2. Amend the 2015 operating grant budget of the Department of Public Health by appropriating the sum of \$200,000 into fund 9300, funds center 5801090000, Public Health Preparedness.
3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

Honorable Legislators:

I recommend that Your Honorable Body accept a five-year grant from the New York State Department of Health, in an amount not to exceed \$26,015, for the Beach Act Program, for the period of October 1, 2014 through September 30, 2019.

The purpose of this grant is to support the water quality monitoring program for the swimming areas at Ontario Beach and Durand Eastman Beach. Monroe County currently monitors the suitability of the swimming areas at these beaches and will continue this effort to comply with New York State and Federal regulations. Funds will be used to support a portion of the salary and benefits of existing positions. This will be the thirteenth year the County has received this grant. This year's funding represents an increase of \$2,755 from the previous 12-month period.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a grant in an amount not to exceed \$26,015 from, and to execute a contract and any amendments thereto with, the New York State Department of Health, for the Beach Act Program, for the period of October 1, 2014 through September 30, 2019.

By Resolution 341 of 2014, Your Honorable Body authorized the acceptance of a grant from the U.S. Department of Housing and Urban Development for the Lead-Based Paint Hazard Control Program. This contract will support the County's Lead-Based Paint Hazard Control Program. Cornell University will provide Environmental Protection Agency certified renovation, repair and painting training for contractors and property owners who engage in maintenance of their own properties or who are interested in learning how to maintain a lead safe home.

A request for proposals was issued and Cornell University was selected as the most qualified to provide these services.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Cornell University, 373 Pine Tree Road, Ithaca, New York, 14850, for the Lead-Based Paint Hazard Control Program, in an amount not to exceed \$30,600, for the period of April 1, 2015 through November 30, 2017.

Environmental assessments were completed for this contract and it was determined that there would be no significant effect on the environment.

Honorable Legislators:

I recommend that Your Honorable Body authorize an intermunicipal agreement with the City of Rochester, in an amount not to exceed \$10,000, for Monroe County to provide water quality monitoring for the beach at Durand Eastman Park, for the period of April 15, 2015 through December 31, 2015, with two (2) one-year options to renew at Monroe County's discretion.

Under the terms of the intermunicipal agreement, Monroe County will provide water quality sample collection, analytical services, and interpretation of results. The sampling results from the previous seasons will be used to refine an operational model similar to the one employed at Ontario Beach. The final parameters for the model shall be determined by the Monroe County Department of Public Health and will be used to make decisions on whether to open or close the beach for water quality reasons at Durand Eastman Park. Monroe County will be reimbursed by the City of Rochester on a fee-for-service basis.

The specific legislative action required is to authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with the City of Rochester, for Monroe County to provide water quality monitoring for the beach at Durand Eastman Park, in an amount not to exceed \$10,000, for the period of April 15, 2015 through December 31, 2015, with two (2) one-year options to renew at Monroe County's discretion.

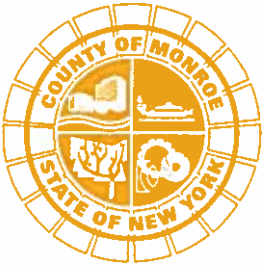

Subject: Publication of Unpaid Taxes

Honorable Legislators:

I recommend that Your Honorable Body, in accordance with Section 18 of the Monroe County Tax Act, authorize the County Treasurer to publish in The Daily Record the list of lands with unpaid taxes and to charge a fee of \$7.00 to cover the cost of the publications, which will be added to the unpaid amounts due for such parcel. In addition, I will direct the Department of Communications to post the list of lands with unpaid taxes on the County's website (www.monroecounty.gov), and notice thereof will be provided to the local news media.

To comply with the provisions of Section 18, a list of lands charged with unpaid taxes must be published and printed annually. Such publication should take place on August 15, 2015, together with a notice that each tax sale certificate will be sold on August 20, 2015 in the County Treasury. In addition to the publication of the list of lands, a notice of said publication calling the attention of the public and all persons interested that a list of lands charged with unpaid taxes will be available and the notice shall be published in The Rochester Business Journal for four (4) consecutive weeks and in The Daily Record for thirty (30) days prior to August 1.

The specific legislative action required is to direct the County Treasurer to publish in The Daily Record the list of lands charged with unpaid taxes, and the notice of publication of the list in both The Daily Record and The Rochester Business Journal, and to authorize the charge of \$7.00 per parcel for such publications.

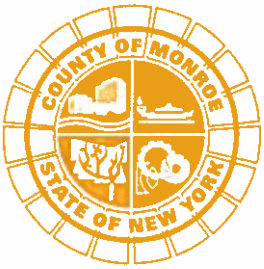
