**Re: Memorializing New York State Assembly to Pass Legislation to Stop
Unfunded Mandates (S.3144A), Returning Control to Local Governments
on Behalf of Their Residents**

Honorable Legislators:

Unfunded mandates from New York State continue to burden counties and local taxpayers. In order to ease the financial burden New York State has imposed on taxpayers, the New York State Senate passed bill S.3144A entitled, "An Act to Amend the General Municipal Law and the Education Law, In Relation to Requiring the State to Fund Certain Programs Mandated for Municipal Corporations and School Districts; and to Amend the Education Law, in Relation to the Effect of Mandates on School Districts".

Unlike local service decisions, State mandated programs place local taxpayers and local officials in the position of paying for services for which they have little to no control. Increasingly, however, the state has set local priorities and forced municipal taxing decisions by mandating services, programs, and standards. As a result, local governments and school districts are forced into an overly burdensome fiscal situation.

In order to prevent irresponsible state actions which, prevent localities from making their own decisions, and which increase fiscal stress on municipalities leading to unwanted local property tax increases, bill S.3144A would ensure that state mandates will not be forced on localities and school districts unless they are adequately funded.

Unfortunately, the New York State Assembly has not yet passed this bill, preventing it from moving forward to the Governor for signature and final adoption. Therefore, I ask that you join me in urging the Assembly to pass bill S.3144A, which will restore local control over the use of revenues and allow local leaders to set policy and prioritize spending on items that benefit Monroe County residents.

RE: Memorializing the United States Congress to Pass, and President Barack Obama to Sign, HR 1076 and S551, the 'Denying Firearms and Explosives to Dangerous Terrorists Act of 2015.'

Honorable Legislators:

The recent massacre of 49 people at a gay nightclub in Orlando was a tragic and horrific event that has left our nation grieving alongside the victims' families. After a gruesome attack like this, we often ask many questions to find out if something could have been done to prevent it. There are times when even hindsight doesn't provide a clear answer and the circumstances of each situation differ. However, in this case, there was a commonsense solution available, but not enacted, that may have thwarted the shooter from arming himself in the first place.

In 2015, the 'Denying Firearms and Explosives to Dangerous Terrorists Act of 2015' was introduced by Congressman Peter King of New York in the House of Representatives and Senator Dianne Feinstein of California introduced a similar measure in the United States Senate. This bipartisan legislation empowers the Attorney General to deny the transfer of firearms or the issuance of a federal firearms and explosives license to any individual if there is a determination that the individual has been engaged in or has provided support for terrorist activities and has a reasonable belief that the individual may use a firearm or an explosive in connection with terrorism. In an effort to preserve due process, it also allows any individual whose firearm or explosives license application has been denied to bring legal action to challenge the denial.

This legislation could have prevented this tragedy because the shooter had previously been on the FBI's Terrorist Watch List. Knowing that this tragedy could have been prevented

adds to the heartbreak we are feeling. However, that knowledge should drive us to support this legislation so that maybe the next terrorist attack can be prevented, and we can all feel safer that firearms and explosives will be more difficult for those on the Terrorist Watch List to obtain. While it is impossible to legislate good behavior, it is possible to use the resources of hard working law enforcement agencies across our nation to prevent weapons from being accessible to those we know are a potential threat.

Therefore, we humbly ask you to join us in memorializing the United States Congress to pass, and President Barack Obama to sign, HR 1076 and S551, the 'Denying Firearms and Explosives to Dangerous Terrorists Act of 2015.'

RE: Memorializing New York State Assembly to pass Assembly Bill 10371, An act to amend the election law, in relation to establishing an electronic registration process integrated within designated agency applications

Honorable Legislators:

Voting is a fundamental right, and registering to vote should be an uncomplicated process. State and local governments have the ability to provide the state board of elections information relevant to voter registration as part of their normal interactions with citizens. With the advance of information technology, electronic registration can be simplified for voters.

Electronic voter registration will allow citizens to complete a form online separately, and/or during the normal course of business with a state agency. Only the voter information is submitted to election officials, which is reviewed and confirmed valid. Currently, this process is offered through the NYS Department of Motor Vehicles when conducting DMV business.

As of June 2016 a total of 31 states plus the District of Columbia offer online registration, and another seven states have passed legislation to create online voter registration systems. Online voter registration systems supplement the traditional paper-based process. In all states, paper registration forms are available for anyone, including those who cannot register online.

Therefore, we urge you to join us in memorializing the New York State Assembly to pass Assembly Bill 10371, An act to amend the election law, in relation to establishing an electronic registration process integrated within designated agency applications

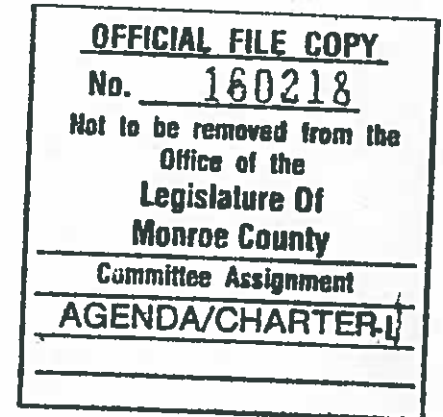



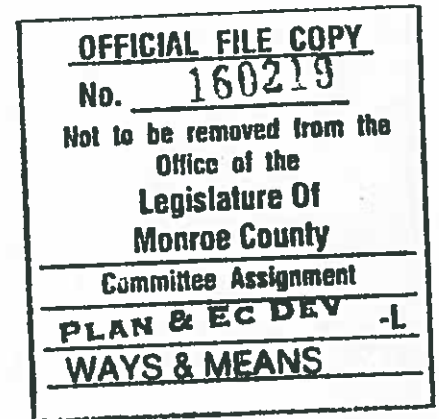

Subject: Acceptance of a Grant from the County of Monroe Industrial Development Agency

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the County of Monroe Industrial Development Agency (COMIDA), in the amount of \$270,000, for economic development activities, staff services and office expenses, for the period of January 1, 2016 through December 31, 2016.

These funds will be made available to the Monroe County Department of Planning and Development (MCDPD) to support activities to encourage the growth of jobs and businesses in the County; \$245,000 of these funds will be utilized to support MCDPD staff and programs; \$25,000 will be used for office expense reimbursement. In addition to providing staff services to COMIDA, the MCDPD conducts a Business Outreach Program, provides financial packaging and technical assistance to businesses and municipalities, coordinates planning and employment and training activities, and provides marketing and data to a wide variety of local businesses. This will be the 23rd year the County has received this grant. This year's funding represents the same amount as last year.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$270,000 grant from, and to execute a contract and any amendments thereto with, the County of Monroe Industrial Development Agency, for economic development activities, staff services and office expenses, for the period of January 1, 2016 through December 31, 2016.
2. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

3. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the Monroe County Industrial Development Corporation (MCIDC), in the amount of \$90,000, to support economic development activities in Monroe County, for the period of January 1, 2016 through December 31, 2016.

These funds will be used to support economic development activities in the County. This will be the 14th year the County has contributed to the GRE. This year's funding represents the same amount as last year.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with the Greater Rochester Enterprise, Inc., for general operating support, in the amount of \$50,000, for the period of January 1, 2016 through December 31, 2016.

Funding for this contract is included in the 2016 operating budget of the Planning and Development Department, fund 9001, funds center 1403010000, Economic Development. No additional net County support is required in the current Monroe County budget.

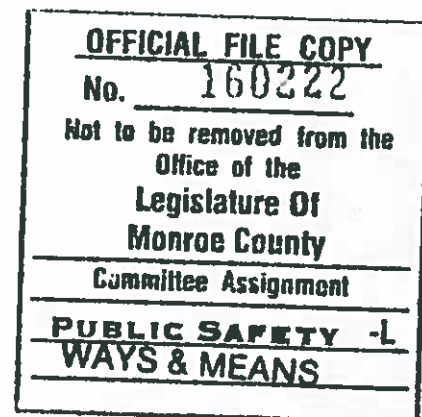

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the New York State Division of Homeland Security and Emergency Services Office of Fire Prevention and Control, in the amount of \$5,000, for the Arson Laboratory Improvement Program, for consumable supplies and related materials necessary for analysis and testing of fire evidence debris, for the period of January 1, 2016 through December 31, 2016.

This grant will enable the Monroe County Crime Laboratory, which serves an eight-county area, to purchase laboratory supplies and related materials necessary to process evidence in the Fire Debris Section of the Crime Laboratory. The County has received this funding since the mid 1980's.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$5,000 grant from, and to execute a contract and any amendments thereto with, the New York State Division of Homeland Security and Emergency Services Office of Fire Prevention and Control, for the Arson Laboratory Improvement Program, for consumable supplies and related materials necessary for analysis and testing of fire evidence debris, for the period of January 1, 2016 through December 31, 2016.
2. Amend the 2016 operating grant budget of the Department of Public Safety by appropriating the sum of \$5,000 into fund 9300, funds center 2408040100, Monroe County Crime Laboratory.


3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.

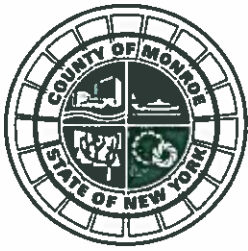

Subject: Acceptance of Three Alternatives to Incarceration Grants from the New York State Division of Criminal Justice Services for the Pretrial Program, Enhanced Pretrial Program, and Domicile Restriction Program

Honorable Legislators:

I recommend that Your Honorable Body accept three (3) Alternatives to Incarceration (ATI) grants from the New York State Division of Criminal Justice Services, the first in the amount of \$170,494, for the Pretrial Program, the second in the amount of \$105,533, for the Enhanced Pretrial Program, and the third in the amount of \$51,961, for the Domicile Restriction Program, all for the period of July 1, 2016 through June 30, 2017.

The goal of all ATI programs is to reduce recidivism, promote public safety, and enhance defendant/offender accountability through community corrections. Probation Officers and Pretrial Services Corporation staff interview defendants to determine if any ATI programs would be appropriate for the defendant.

The Pretrial Program provides universal screening for defendants arrested and detained in the Monroe County Jail. The program staff interview defendants, verify information given and communicate that information to the Court in order to assist a qualified defendant in obtaining release on his/her own recognizance in lieu of money bail or pre-trial detention. If the defendant is released to the program, he/she is monitored to ensure attendance at subsequent Court appearances.

The Enhanced Pretrial Program provides intensive monitoring of a defendant by an individual case manager. An additional treatment component may be required of the defendant. The Program team links defendants with treatment programs, monitors defendant progress, and makes recommendations to the court for adjustment/modification. Monitoring occurs through personal and telephone contacts and continues at least twice per week until case disposition.

The Domicile Restriction Program provides an alternative to incarceration by the use of electronic monitoring of offenders. The program includes traditional phone monitoring, Global Positioning System monitoring and alcohol sensing equipment for high-risk offenders. By placing offenders in this program, the County saves money, and the offender has the opportunity to continue their employment, schooling, and/or treatment and maintain familial ties, thereby reducing their chance of re-offending.

The two (2) pretrial programs will be provided by Pre-Trial Services Corporation of the Monroe County Bar Association. The Domicile Restriction Program will be administered by staff from the Monroe County Office of Probation - Community Corrections. This will be the twenty-fourth year that the County has received these grants. This year's funding represents the same amount as last year.

Subject: Authorize an Intermunicipal Agreement with the City of Rochester to Accept Pass Through Funding from the United States Department of Justice for the 2016 Edward Byrne Memorial Justice Assistance Grant Program

Honorable Legislators:

I recommend that Your Honorable Body authorize an intermunicipal agreement with the City of Rochester to accept pass through funding from the United States Department of Justice, in the amount of \$81,070, for the 2016 Edward Byrne Memorial Justice Assistance Grant Program, for the period of October 1, 2016 through September 30, 2017.

This grant will be used to continue funding the salaries of two (2) Probation Officers who provide intensive supervision of high-risk adult and juvenile probationers by performing field checks to document violation of curfew conditions of court-ordered Probation. The success of this effort is contingent upon surprise, unannounced night visits to probationers' homes by teams of Probation Officers and Rochester Police Officers through Operation Nightwatch. This is the eighteenth year that Monroe County has received funding for this program. This year's funding represents an increase of \$2,729.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with the City of Rochester, to accept pass through funding from the United States Department of Justice, in the amount of \$81,070, for the 2016 Edward Byrne Memorial Justice Assistance Grant Program, for the period of October 1, 2016 through September 30, 2017.
2. Amend the 2016 operating grant budget of the Department of Public Safety, Office of Probation and Community Corrections, by appropriating the sum of \$61,448 into fund 9300, funds center 2403040000, Supervision General.
3. Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body authorize a contract with Monroe #1 Board of Cooperative Educational Services ("BOCES #1"), in the amount of \$93,793, for reimbursement to the Monroe County Sheriff's Office School Resource Program, for the period of September 1, 2016 through June 30, 2017.

BOCES #1 will be provided a full-time Monroe County Sheriff's School Resource Officer ("SRO") during the 180-day school year, plus an additional 10 administrative days. The SRO's primary duty is to maintain an atmosphere where students, teachers and staff feel safe. The SRO may assist in the investigation of suspected criminal activity occurring on BOCES #1 property and/or related to BOCES #1. This assistance shall be provided in consultation with school administrators, in accordance with New York State Law and BOCES #1 policy. As an educator, working with classroom teachers and other BOCES #1 personnel, the SRO may present information and answer questions on a variety of topics, such as the law, drugs, safety, crime prevention, violence prevention, concepts of safety, traffic laws, general law, and crime prevention techniques. The goal of the presentations is to increase student, staff, and community awareness and understanding of laws and personal safety. The SRO shall also perform such other security and/or law enforcement services as may be reasonably assigned by the District Superintendent, in consultation with the Sheriff, as appropriate.

This will be the third year the Sheriff's Office has participated in the SRO Program at BOCES #1. BOCES #1 will fund the salary and fringes associated with the Sheriff's Office SRO assigned during the 180 day school year, plus an additional 10 administrative days.


The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with Monroe #1 Board of Cooperative Educational Services, 41 O'Connor Road, Fairport, New York 14450, in the amount of \$93,793, for reimbursement to the Monroe County Sheriff's School Resource Program, for the period of September 1, 2016 through June 30, 2017.

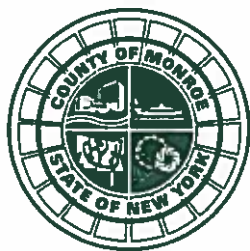

The Department of Environmental Services will convert ten (10) vehicles from using gasoline to propane (LPG) and purchase five (5) hybrid vehicles and one (1) fully electrically powered vehicle. The grant provides 75% of the cost for this conversion with Monroe County being responsible for the remaining 25%. The estimated payback due to reduced fuel costs is less than three (3) years. In addition, these conversions will reduce greenhouse gas emissions from use of these vehicles by 39% versus gasoline.

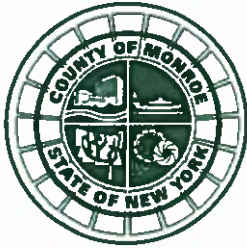



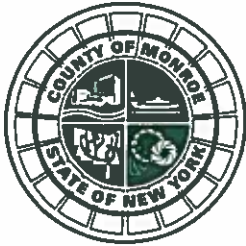

Subject: Amend Resolution 406 of 2015 to Amend and Increase the Contract with the University of Rochester Pulmonary Group for the Monroe County Department of Public Health Tuberculosis Control Program

Honorable Legislators:

I recommend that Your Honorable Body amend Resolution 406 of 2015 to amend and increase the contract with the University of Rochester Pulmonary Group, from an amount not to exceed \$113,840 to an amount not to exceed \$116,117, for physician services for the Monroe County Department of Public Health Tuberculosis (TB) Control Program, for the period of January 1, 2016 through December 31, 2016, with the option to renew for one (1) additional one-year term, in an amount not to exceed \$118,440.

This contract will support the County's TB Control Program. The University of Rochester Pulmonary Group will provide contracted physicians for the purpose of diagnosis, consultation and supervision of treatment for TB and related pulmonary diseases of patients at the TB Clinic. The additional dollars will support bi-weekly educational sessions conducted by the TB Pulmonary Group.

A Request for Qualifications was issued for this contract with the University of Rochester Pulmonary Group the sole responder.

The specific legislative action required is to amend Resolution 406 of 2015 to amend and increase the contract with the University of Rochester Pulmonary Group, 601 Elmwood Avenue, Rochester, New York, 14642, for physician services for the Monroe County Department of Public Health Tuberculosis Control Program, from an amount not to exceed \$113,840 to an amount not to exceed \$116,117, for the period of January 1, 2016 through December 31, 2016, with the option to renew for one (1) additional one-year term, in an amount not to exceed \$118,440.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract is included in the 2016 operating budget of the Department of Public Health, fund 9001, funds center 5802020000, Tuberculosis Control Programs and will be requested in future years' budgets. No additional net County support is required in the current Monroe County budget.

The University of Rochester is a not-for-profit entity, and the records in the Office of the Monroe County Treasurer have indicated that it does not owe any delinquent Monroe County property taxes.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

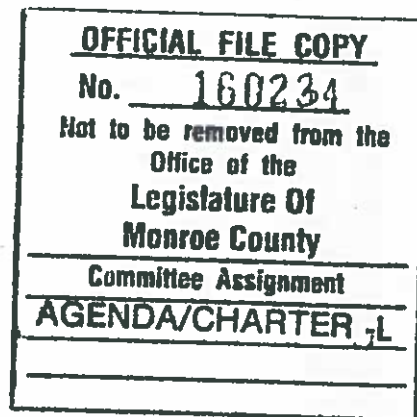

Honorable Legislators:

I recommend that Your Honorable Body enact a local law amending the County Charter to amend the Public Health Commissioner position.

By New York State law and regulations, Monroe County is required to have a physician in the position of Public Health Commissioner for our local health district. The Commissioner of Public Health should not only be well equipped to manage the department as part of the leadership of the County but also should be current with his or her qualifications and/or credentials. Amending the County Charter to allow this individual to engage in the private practice of medicine in addition to his/her duties to the County would ensure Monroe County not only has a well-qualified individual to lead the department but also would stay up to date with the latest changes in the clinical aspect of the practice.

The specific legislative actions required are:

1. Schedule and hold a Public hearing on the proposed Local Law.
2. Enact a Local Law to amend the Monroe County Charter to amend the Department of Public Health Commissioner position.

This proposed Local Law will require no additional net County support in the current Monroe County budget.

LOCAL LAW NO. ____ OF 2016

ENACTING A LOCAL LAW AMENDING THE MONROE COUNTY CHARTER TO AMEND THE DEPARTMENT OF PUBLIC HEALTH COMMISSIONER POSITION

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

5019 JNF - 8 PM 15:14

Section 1. Section C6-12(F) of the Monroe County Charter is amended to read as follows:

(F) Commissioner; appointment; term; compensation; contract for services. The County Executive shall appoint a County Commissioner of Public Health who shall be the administrative head of the County Department of Public Health. The Board of Health of each County or part-County health district may recommend to the County Executive for appointment as County Commissioner of Public Health a person or persons whom it deems qualified for such office. The County Commissioner of Public Health shall possess such qualifications for office as are prescribed in the Sanitary Code of the State of New York. The County Commissioner of Public Health shall receive such compensation as may be fixed by the County Legislature. In the alternative, the County Executive may contract with an appropriate hospital or facility in the County for the provision of all or part of the commissioner services required for the Department of Public Health. The contract may contain such terms and conditions as the County Executive deems necessary. Such contract shall require approval of the County Legislature.

Section 2. Section C6-12(G) of the Monroe County Charter is amended to read as follows:

(G) Powers and Duties. ~~The County Commissioner of Public Health shall devote his or her entire time to the duties of his or her office except that in a County operating as a County Health district, the boundaries of which are coterminous with the County, he or she may, with the approval of the Commissioner of Health of the State of New York, be appointed Superintendent of the County General Hospital or County Medical Examiner.~~ The County Commissioner of Public Health shall, ~~within his or her district,~~ possess all the powers conferred upon and perform all the duties required of local health officers or commissioners under the Public Health Law of the State of New York or other applicable law. In consideration for keeping all certifications and clinical qualifications current, the County Commissioner of Public Health may, with prior approval from the County Executive, engage in the practice of medicine in addition to his or her duties as commissioner.

Section 3. This local law shall take effect in accordance with the provisions of the Municipal Home Rule Law and the Monroe County Charter.

Subject: Accept Additional Funding from the New York State Department of Transportation for the State Supported Consolidated Local Street and Highway Improvement Program

Honorable Legislators:

I recommend that Your Honorable Body accept additional funding from New York State Department of Transportation, in the amount of \$1,170,487.85, for the State Supported Consolidated Local Street and Highway Improvement Program.

The State Supported Consolidated Local Street and Highway Improvement Program supports the cost of highway and bridge maintenance throughout Monroe County. The New York State Department of Transportation budget included a new program entitled PAVE-NY which provided additional funding to the Consolidated Local Street and Highway Program (CHIPS). Therefore, pursuant to the recently approved FY 2016-2017 New York State Budget, Monroe County will receive an additional \$1,170,487.85.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept additional funding from the New York State Department of Transportation, in the amount of \$1,170,487.85, for the State Supported Consolidated Local Street and Highway Improvement Program, bringing the total funding amount to \$6,545,487.85.
2. Amend the 2016 operating budget of the Department of Transportation, by appropriating the sum of \$1,170,487.85 into fund 9002, funds center 8002050000, State Supported Consolidated Local Street and Highway Improvement Program.

3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This program is 100% funded by the New York State Department of Transportation. No additional net County support is required in the current Monroe County budget.
